

Entry Policy for Vehicle Inspections

Work, Health and Safety Requirements

Notice to Drivers & Other Personnel

To ensure the work health and safety of vehicle examiners, drivers and other persons at a depot and surrounding yard area including any workshop area (**depot**) where TBA Services Pty Ltd vehicle examiners are undertaking vehicle inspections, drivers and any other persons must comply with the following rules:

1. The workshop or vehicle inspection area within the depot is not to be entered without authorisation from the vehicle examiner or the depot operator or the depot operator's representative
2. Drivers and others must follow all directions given by the vehicle examiner when entering the workshop or vehicle inspection area to present the vehicle for inspection. The vehicle examiner will advise the driver when to stop and start the vehicle, when to apply parking and other brakes and when to adjust gears.
3. Drivers and other persons must remain in the vehicle unless requested to leave the vehicle by the vehicle examiner or the depot operator or the depot operator's representative.
4. Safety vests or other high visibility clothing and other required personal protective equipment (PPE) must be worn correctly at all times by drivers and other persons within the depot. Carrying your safety vest or other high visibility clothing is not acceptable.
5. When a driver or other persons leave the vehicle, he or she must be signed in to the depot by the depot operator or the depot operator's representative and be advised of all rules, policies and guidelines for pedestrians and visitors at the depot.
6. All persons, including drivers must obey all speed limit and other safety signs upon entering the depot.
7. The speed limit within any depot for the purposes of any vehicle inspection is walking pace (**5km**) unless otherwise directed by the vehicle examiner or the depot operator's representative.
8. When reversing a vehicle within the depot, the driver must sound the horn and use hazard lights.
9. No smoking or lighting of cigarettes is permitted within the depot except at any designated smoking area (where applicable) within the depot.
10. No inappropriate conduct, including swearing, bullying or aggressive behaviour will be tolerated at any time.

Breaches of the above directions may result in formal warnings or offending persons being prohibited from entering the depot for vehicle inspections undertaken by TBA Services Pty Ltd.

COVID-19

TBA Services Pty Ltd effective from Wednesday 25 March will institute changes to vehicle inspections for all vehicles and types to ensure the health and safety of our employees.

There will be changes to how you present the vehicle to us for inspection and by the Vehicle Examiner (VE) in his dealings with you or your driver.

The VE at all times will abide by the government policy on social distancing from other persons.

The VE when checking the interior of the vehicle will at all time wear disposable gloves

We request that all vehicle interior touch points be thoroughly sanitized before being presented for inspection.

- 1 **The Driver must remain in the vehicle at all times as per our current entry policy (that you must bring signed to the inspection).unless directed by the VE to be shown an area on the vehicle such as a Non-Conformance Critical.**
- 2 The workshop or vehicle inspection area within the depot **must not to be entered without authorisation** from the vehicle examiner or the depot operator or the depot operator's representative.
- 3 **Drivers must follow all directions given by the vehicle examiner** when entering the workshop or vehicle inspection area, to present the vehicle for inspection. The vehicle examiner will advise the driver when to stop and start the vehicle, when to apply parking and other brakes.
- 4 **There must be no passengers** in the bus at all times during a vehicle inspection. Passengers who may travel with the driver must be offloaded outside of the inspection premises before entering

Failure by you or your driver to observe any of the above conditions may result in your inspection being discontinued immediately.
